### General Information

- Celebrate Canada Day-Kelowna is open to the public from 11:00 a.m. to 10:30 p.m.; “Kids Zone” is open from 11:00 a.m. to 4:00 p.m. Over 55,000 people pass through the gates between 11:00 a.m. and 10:30 p.m.
- With a goal toward affordable and accessible fun for families, all activities for the Kids Zone must be free to participate unless prior arrangements have been made with organizers and written approval is received.
- Participants are expected to supply their own equipment, although Festivals Kelowna staff can provide assistance with suggesting suppliers (i.e. chairs and tables, tents)
- Participants are welcome to distribute information about their organization but are not permitted to sell or fundraise onsite.
- **Vehicles cannot be driven onto the Rhapsody Plaza for load in or load out;** all equipment must be carried or hand carted into the park. If special help is required, Festivals Kelowna staff can assist participants as long as *prior arrangements* have been made with organizers.

### Application Process:

- Applications are accepted on an ongoing basis until space is allocated
- Applicants are selected based on ensuring a diverse mix of interests and information for the public

**Terms and Conditions:**

- Participants are limited to providing information or conducting a free activity. Participants not respecting this request will be not be invited to future festivals.
- Participants must be set-up and in place for 11:00 a.m. Groups must staff their booth during “Kids Zone” hours
- Groups are responsible for cleaning up their booth area after tear-down and taking away any garbage their booth generates
- It is understood that this is an outdoor festival, and that the event will proceed in all weather conditions. As such, Groups should be prepared to protect their booth and contents from all weather conditions.
- All structures (tents) must be weighed down using sand bags, weights, water jugs, etc.  
**Staking or attaching to trees is not permitted.**
- The Group agrees that they are solely responsible for their booth and its contents.

*I have read the above conditions and agree to save and hold harmless Festivals Kelowna and any of their officers, agents, servants and employees free from liability for a) any damage to or loss of equipment under this agreement b) any personal injury (including death) associated with the Vendor’s participation under this agreement.
