Products for sale must be appropriate for an all-ages event. Space is allocated through a “first-come, first-served” process with a goal to create a diverse product mix.

Booth Space and Fee

- Applications will be accepted and spots filled as vendor space permits on a first-come, first-served basis. However, in order to encourage product variety we reserve the right to deny an application if there are already multiple vendors with similar products. Approval to the “Canada Day Bazaar” is at the discretion of Festivals Kelowna.
- The Bazaar is located south of the Concession Plaza on the grassy area leading to the Island Stage. Given the space limitations we can only accommodate a *typical set-up* that includes a tent, tables, and product racks. Vehicles or oversized infrastructure is not permitted.
- **NOTE:** Due to ongoing work at the Island Stage in 2025, the Bazaar location may be changed based on site availability. This may include placement closer to the Beach Stage in addition to the usual location (South of the Concession Plaza and Tugboat Beach).
- We will provide a 12x12 space for your booth, but participants are responsible for supplying their own equipment (i.e. tents, tables, chairs). Festivals Kelowna staff can provide information about local suppliers to assist you. Please also note that there is no power available.
- All structures (tents) must be weighed down. The City of Kelowna requires no staking or attaching to other permanent structures
- The **booth fee for the day is \$200 + GST= \$210.00** Payment is due at time of application and payment via e-transfer is preferred. Please submit payment to:

IMPORTANT NOTE: please type in subject line “Canada Day Bazaar payment”. For e-transfer security question answer please use question = “What event is this for?” and answer = “Canadaday”.
- Application deadline is Friday, June 20th, pending space still available.

Set-up

- Vendors may start loading into the site starting at 10:00 am on July 1st. Unfortunately we cannot permit vehicles to drive into the beach area so please plan to cart in your items by hand. **Note:** We will consider allowing set-up of tables and tents in your assigned space the night before but *do not* recommend leaving your products as we cannot guarantee their safety.
- Participants in the Canada Day Bazaar must be set-up and in place for 12:00 p.m. on July 1st
- Limited parking is available in nearby parking lots, however, Festivals Kelowna staff can recommend suitable lots near the event site

Take-down

- Will commence after 9:30pm. If you are still serving customers then you are welcome to stay open until fireworks completion at 10:30
- Vehicles are NOT allowed onto the event site until after audience has cleared and ONLY at approval of Operations Coordinator after 11:00pm

Application Process – It is best to email your application and the final deadline, pending remaining room, will be June 20th. Payments received after this date must be in cash or e-transfer. Notification of acceptance will take place via email or telephone from Festivals Kelowna
